1. Call for proposals for Town Twinning (CERV-2024-CITIZENS-TOWN-TT)

European Commission had launched the Call for proposals for Town Twinning. The objective of this call is to promote exchanges between citizens of different countries, in particular through town twinning, to give them practical experience of the wealth and diversity of the common heritage of the Union and to make them aware that these constitute the foundation for a common future.

Opening date: 09 April 2024 Deadline date: 19 September 2024 17:00 Brussels time Budget (EUR): 4 000 000

3. Remedies 2nd Open Call for Associate Regions: Prevention & Zero-waste solutions

The REMEDIES 2nd Open Call for Associate Regions: Prevention & Zero-waste solutions (REMEDIES OC2) offers grants of up to €100K to local and regional associated regions for initiatives aimed at aquatic ecosystem restoration. Technical assistance and advisory services will be provided to implement proposed actions, with regular monthly meetings and milestone tracking facilitated by REMEDIES mentors. The funding period spans from September 11, 2024, to May 10, 2025, with an OC2 Kick-off Meeting and closing event planned.

The European Commission has invited all European Territorial Cooperation Programmes to join the **INTERREG consultation 2024** on the future Cohesion policy (post 2027). <u>URBACT</u> will start this consultation process with an EU survey. Whether you are a European city representative, an urban practitioner, or an active citizen, share your input to shape the future of URBACT and of European territorial cooperation for the years after 2027. The survey will run **from 26 March to 31 July 2024** and is available <u>here</u>.

3. 2024 Territorial Peer review on demographic change

We are delighted to announce the open call for applications for the 2024 territorial peer review on integrated development strategies in non-urban areas. The main topic of this edition is demographic change, however, all non-urban 2021-2027 strategies are eligible to apply.

What is this open call about?

The peer reviews are an in-person two-day workshop based on an innovative methodology that will allow local authorities to receive insights and tailor-made advice from European colleagues (peers) and experts on how to improve the development and implementation of their strategy. The peer review workshop **will take place** in **mid-June 2024** (place and exact dates will be confirmed following expression of interest from the co-hosting territory).
